The Financial Up-gradation under MACP Scheme shall however be subject to the terms and conditions mentioned in DoPT OM No.35034/3/2015-Estt.(D) dated 22.10.2019 and subsequent clarifications issued by Hqrs. Office on the subject from time to time. Further the cases of the officials holding a higher post on purely ad-hoc basis before the date of recommendation of financial up-gradation, if any, may be regulated as per Para 25 of Annexure-I of DoPT OM dated 22.10.2019.

On up-gradation under the MACP Scheme, pay of an officer/ official shall be fixed as per Para 4 to 7 of Annexure-I DoPT OM dated 22.10.2019 and the officer/ official shall have to exercise the option of fixation of pay, within one month from the date of issue of this order, under the provisions of FR-22(I)(a)(1). The pay and the date of increment would be fixed in accordance with Rule 10 of CCS (RP) Rules, 2016. Before allowing the financial up-gradation as per the details above, the Medical Superintendent may verify the details of each officer/ official concerned from their service records. Discrepancy, if any, may be immediately brought to the notice of this office.

The Controlling Authorities may ensure the relevant entries of the Office Order in the Service Records of the concerned officers/ officials and necessary action regarding pay fixation may be initiated.
