As per the HQrs letter No. A-12/11/2/RR-Pharma. /2017-Med-VI dated 19/02/2021 the Nomenclature of the Officials at SL No. 3, 8, 9, 10,11 & 12 will be changed to Pharmacy Office [NFG] w.e.f the date of grant of MACP.

The Financial upgradation under MACP Scheme shall however be subject to the terms and conditions mentioned in DoPT OM No. 35034/3/2015-Estt. [D] dated 22/10/2019 and subsequent clarifications issued by Headquarters Office on the subject from time to time. Further the cases of the officials holding a higher post on purely adhoc basis before the date of recommendation of financial up-gradation, if any, may be regulated as per Para 25 of Annexure – I of DoPT OM dated 22/10/2019.

On Upgradation under the MACP Scheme the pay of an official shall be fixed as per Para – 4 to 7 of Annexure – I of DoPT OM dated 22/10/2018 and the official shall have to exercise the option of fixation of pay, within one month from the date of issue of this order, under the provisions of FR-22 [a] [1]. The pay and the date of increment would be fixed in accordance with Rule 10 of CCS [RP] Rules, 2016. Before allowing the Financial Upgradation as per the details above, the Medical Superintendent may verify the details of each official concerned from their service records. Discrepancy, if any, may be immediately brought to the notice of this Office.

The Controlling Authorities may ensure the relevant entries of the Office Order are made in the Service Books of the concerned Officials and necessary action regarding pay fixation may be initiated.
